## DRESS, GROOMING, AND PERSONAL APPEARANCE

The dress, grooming and personal appearance of all that enter the Probation Department's grounds should project and enhance a positive and professional image and be appropriate to your assignment and responsibilities. Personal appearance must reflect the professional nature of the department's role as part of the criminal justice system and not be distracting to the safe operations. Extremes in dress and grooming that are inconsistent with the mission of the Department are not acceptable. Anyone entering a juvenile facility whose attire or appearance is not appropriate may be directed to leave the site and return suitably dressed and groomed. These guidelines are not intended to prohibit one's personal preference in wardrobe. However, it requires that extremes in fashion not be displayed at the site. All dress and appearance should convey a positive, professional role model to Justice-Involved individuals.

#### **Appropriate Clothing**

#### Males:

- · Pants or jeans
- · Shirts or sweater with sleeves (T-shirts are not appropriate)
- · Safe footwear, closed- toed with non-skid soles and socks must be worn
- All clothing must be appropriately fitted and free of writing, pictures or advertising that supports illegal activity or negative content, i.e., alcohol, smoking, nudity or criminal lifestyle.

#### Females:

- · Pants or jeans
- · Shirts, sweaters, or blouses with sleeves (T-shirts are not appropriate)
- · Safe footwear, closed- toed with non-skid soles and socks must be worn
- All clothing must be appropriately fitted and free of writing, pictures or advertising that supports illegal activity or negative content i.e., alcohol, smoking, nudity or criminal lifestyle.

#### **Inappropriate Clothing**

- · Recreational attire is inappropriate. (Running shoes are fine).
- . Tank tops, low cut tops, skirts, shorts, leggings, jeans with holes, workout clothing, and undershirts.
- Tight, revealing and inadequately covered chest and midriff is unacceptable.
- · Ripped, torn or tattered clothing
- · Shirts depicting any negative behavior (drugs, alcohol, smoking or foul language etc.)
- Inappropriate footwear includes recreational sandals, flip flops, high heels and shower shoes due to safety, appearance and inadequate protection.

### Extremes in Style

Extremes in dress, grooming, hairstyle or makeup are not appropriate. Visible body art, i.e. inappropriate tattoos and excessive body piercing should be concealed.

#### Grooming

Personal grooming and hygiene must reflect neatness and cleanliness. Haircut/hairstyle and beard/mustache must be clean and neatly trimmed. Clothing must be clean and properly fitted.
